ELIGIBILITY

This trial is open to all dogs 20" or less and over the age of 12 months, Except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Your dog must be registered with TDAA to participate in TDAA Trials.

There is a registration form included in this premium, or you can register the first day of the trial. TDAA rules can be obtained online in the form of a PDF file at www.k9tdaa.com

CLASS INFORMATION

Standard Classes

Beginner Agility – All dogs shall be eligible for participation in this class.

Intermediate Agility - Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

Superior Agility – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) or Teacup Superior Agile Dog (TSAD) shall be eligible for participation in this class.

Games Classes

Games I – All dogs shall be eligible for participation in this class.

Games II – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

Games III – Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

GAMES

Power and Speed

Power and Speed is a two part game. In the first part [Power] the dog will run an un-timed sequence of mostly technical obstacles; and in the second part [Speed] the dog will run a timed jumpers course. *Power and Speed* is scored Time, Plus Faults. ER5

Twister

Twister is a point accumulation game in which the dog earns points for sequences of obstacles arranged in two concentric loops. The dog is required to change the direction of play between scoring sequences, alternating between the inner and outer loops. *Twister* is scored Points, Then Time. ER2

Twelve Tone Row

Twelve Tone Row is a dog's-choice game in which exactly 12 obstacles must be performed for points. Each obstacle has a different value; and sometimes a single obstacle has different values depending on the direction taken. The 12th obstacle is required to be an obstacle designated by the judge (usually the weave poles). *Twelve-Tone Row* is scored Points, Minus Faults, Then Time. ER6

Helter Skelter

Helter Skelter is a game of speed and skill, played on a numbered course consisting of obstacles arranged in a spiral that builds speed. *Helter Skelter* is scored Time, Plus Faults. ER5

JUDGE'S BRIEFING ON DAY OF TRIAL SUPERSEDES
ANY PREVIOUS BRIEFINGS.

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * All dogs must be on leash or crated at all times except when in the ring or when in designated areas, being the warm-up area and the designated off leash area. It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial Committee, be asked to leave the trial site.
- * In such case, no refund of any fees will be made.
- * Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- * Exhibitors are responsible for being at the ring gate when it is their turn to run.
- * Exhibitors may wear shirts or insignia of their training group if they wish.
- * At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- * Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at www.k9tdaa.com
- * Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- * **Photocopied entries without the TDAA agreement on the back are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- * The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- * No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.
- * Bitches in season are not permitted at the trial. The club will refund all but \$5.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such claim for refund by letter (not email) before June 26, 2017

HEIGHT DIVISIONS

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a lower than their proper height division. Dogs that run in a height division lower than their division will be eliminated. A judge must measure provisional dogs.

4" jump height - restricted to dogs measuring 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less

8" jump height - restricted to dogs measuring 12" or less at the withers; or dogs with a jump height exemption measuring 15" or less.

12" jump height – restricted to dogs measuring 15" or less at the withers; or dogs with a jump height exemption measuring 20" or less.

16" jump height – restricted to dogs measuring 20" or less at the withers.

Special provisions are made for the dogs that are long-backed, or dogs whose depth of chest is greater than his legs length.

E1 - Long backed dogs – The long-backed dog would be based on the measurements of the dog from the front of the chest to the back of his rear compared to the measurement of the dog's height at the withers. As a rule of thumb, if the dog's length is 150% or greater than the height measurement, the dog would qualify for this exemption.

E2 - Weight to length provision (by structure, not obesity) – This exemption should be limited to certain breeds that have a propensity for weight that is greater than their height if you compare pounds to inches.

E3 - Dogs with dwarfish legs/deep chest dogs – This exemption is granted to dogs whose leg to shoulders height ratio is 1/3 or less of the dog's overall height. The exemption for dog's with dwarfish legs in based on the measurement of the dog's withers height, when that height is 150% or greater than the measurement of the space from the floor to chest veteran dog is a dog at least 7 years of age. There is no special system of titling for veteran dogs.

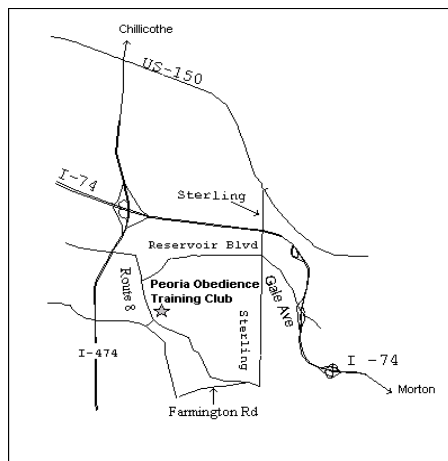
Handicapped Handlers: Disabled handlers will be allowed an additional 4 seconds in Standard and Games classes using numbered courses. A copy of a disabled parking permit must be sent with the entry.
