AWARDS: Ribbons will be awarded for 1st through 3rd in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying score. Dogs may receive placement ribbons without qualifying. Fast track dogs will only get Qualifying ribbons at the Beginner/Games I and Intermediate/Games II levels.

CLASS INFORMATION

Standard Class

Beginner Agility – All dogs shall be eligible for participation in this class.

Intermediate Agility - Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

Superior Agility – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

Games Classes

Games I – All dogs shall be eligible for participation in this class.

Games II – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

Games III – Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

GAMES

Tag 10

The purpose of Tag 10 is to accumulate points in 10-point blocks and to accumulate as many of those 10-point sets as possible in the time allotted. Weaves not required for Games I to qualify.

Beat the Clock

The objective is for the team to perform the clock of obstacles before the time runs out. There are groups of three obstacles for each quarter of the clock. Weaves not required for Games I to qualify.

Copycat

Copycat is a dog's choice game. That means the handler can direct the dog through the performance of obstacles in the order and direction of his own choosing, or the dog's choosing as the case may be. The dog can perform each obstacle only twice for points. If the dog performs the same type of obstacle back-to-back, called copycatting (for example, 2-one point, 2-three point or 2-five pointers) the team will lose points.

Helter Skelter

This game is run on a jumpers course and will contain jumps, tunnels and weaves. Weaves will not be used in Games I. The dog is required to attempt each obstacle.

Fast Track Move-Ups: Titles may be grandfathered from other organizations on a "Fast Track" basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move up from Beginner to Superior on the same day if the dog qualifies first in Beginners and again in Intermediate. A qualifying score in the lower class is required to move up to the next higher class. Likewise, a dog can move up from Games I to Games III by earning qualifying scores in the lower two levels. The dog's owner must submit a copy of title certificates for the dog. **Please mark each that apply and submit \$8.00 with this FAST TRACK Move-Up Request form. Payment of the \$8.00 is not a guarantee that your dog will qualify at the lower level and is non-refundable. The Fast Track fee is a one-time only fee and carries over from trial to trial.**

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * All dogs must be on leash or crated at all times except when in the ring or when in designated areas, being the warm-up area and the designated off leash area. It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made.
- * Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- * Exhibitors are responsible for being at the ring gate when it is their turn to run.
- * Exhibitors may wear shirts or insignia of their training group if they wish.
- * At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- * Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at www.k9tdaa.com
- * Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- * **Photocopied entries without the TDAA agreement on the back are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- * The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- * No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.
- * Bitches in season are not permitted at the trial. The club will refund all but \$5.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such claim for refund by letter (not email) before April 9, 2010.

Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a lower than their proper height division. Dogs that run in a height division lower than their division will be eliminated. A judge must measure provisional dogs.

4" jump height - restricted to dogs measuring 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less

8" jump height - restricted to dogs measuring 12" or less at the withers; or dogs with a jump height exemption measuring 15" or less.

12" jump height – restricted to dogs measuring 15" or less at the withers; or dogs with a jump height exemption measuring 17" or less.

16" jump height – restricted to dogs measuring 17" or less at the withers.

Special provisions are made for the dogs that are long-backed, or dogs whose depth of chest is greater than his legs length.

E1 - Long backed dogs – The long-backed dog would be based on the measurements of the dog from the front of the chest to the back of his rear compared to the measurement of the dog's height at the withers. As a rule of thumb, if the dog's length is 150% or greater than the height measurement, the dog would qualify for this exemption.

E2 - Weight to length provision (by structure, not obesity) – This exemption should be limited to certain breeds that have a propensity for weight that is greater than their height if you compare pounds to inches.

E3 - Dogs with dwarfish legs/deep chest dogs – This exemption is granted to dogs whose leg to shoulders height ratio is 1/3 or less of the dog's overall height. The exemption for dog's with dwarfish legs is based on the measurement of the dog's withers height, when that height is 150% or greater than the measurement of the space from the floor to chest.

E4 - Veteran dog is a dog at least 7 years of age. There is no special system of titling for veteran dogs.

E5 – Handicap Handler (a handicapped parking tag must be presented at check-in)

A dog also may be given an exemption to jump at a lower height even though he does not meet any of the criteria for a jump height exemption. An exemption will be given to a dog for extraordinary circumstances as determined by TDAA.

Dogs given an exemption to a lower jump height will be able to earn qualifying legs and all TDAA titles.

A copy of the dog's jump height card must accompany your trial application or be presented at check-in.

Dogs without a permanent TDAA jump height card must be measured prior to running in this trial.
