VOLUNTEERS will receive a raffle ticket for every class they work for our really fun raffle with cool prizes.
Pick up your dog's poop everywhere on the property, even in the weeds and far away from the building. Don't allow your dog to pee on the building or in the building. Please clean up accidents thoroughly- clean up materials are in the blue buckets.

Directions to show site:

From Cleveland: I480 SE to rt 14 SE for 43.9 miles. To Washingtonville, Oh 44490. Turn rt onto Painters Path (next to Huntington bank. South on Painters Path for 1,600 feet.

From Akron: I76 E to rt 14 SE. then follow above directions.

From the South: RT 7 N. to Rt 11 N. (25.2 miles) to rt 46. at exit ramp turn rt onto rt 46 (2.3 miles). At first traffic light turn right on rt 14 west (4.1 miles). Turn left onto Painters Path at Sky bank in Washingtonville OH 44490. Travel 1,600 feet to building site.

From I 80 Western Pa: I 80 west into Oh Take rt 11 south to SR46. Then follow directions from the south.

Our road, Painters Path, is directly next to Huntington Bank and off of SR 14. It is a gravel road and not on map quest because it is new. We are the only building on the road so you can't miss it. Washingtonville is a speed trap so do not drive over 35mph. Painters Path has a speed limit of 5 mph to keep all dogs safe. To find our address using a map quest program use the address of 799 Main St. in zip code 44490.

LUNCH WILL BE AVAILABLE ON BOTH DAYS.

We will have toys for Qs at this trial.

TDAА now offers FEO (For Exhibition Only). They are open to any dog who is registered with TDAА. FEO dogs will run last in the class. They may run on lead and FEO runs do not count towards TDAА titles. No treats or food is allowed during the run, dogs may not repeat any obstacles; no training in the ring is allowed. FEO entries will be taken day of show only. Teams entered FEO will have up to 1.5 times the SCT for their run.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site.

In such case, no refund of any fees paid will be made.

Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Exhibitors may wear shirts with insignia of their training group if they wish.

At the handler's option, the dog may wear a flat (buckle or quick release) collar without tags or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.

Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

ELIGIBILITY: This event is open to any dog 17" and under, and over the age of 12 months. Exceptions are: bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance.

ENTRIES CLOSE 6:00 p.m April 5, 2010. Day of show entries will be accepted with an additional handling fee of \$2.00 per dog per day.

Anyone who does not clean up after their dog will be removed from the trial with no refund of monies paid.

Games Classes

BLACK JACK: The purpose of this game is to collect exactly 21 points in the shortest amount of time. Accumulating more than 21 points disqualifies the team. The order of the obstacles is the handler's choice. No contact obstacle can be taken back to back weather successful or unsuccessful. No obstacle can be taken more than twice for points. If dog and handler collect 21 points before the end of the game time the team runs to the finish line to stop the time.

DARE TO DOUBLE: This game is a dog choice game which means the team earns points for taking obstacles in the order and directions of his choosing. The team has 50 seconds to accumulate as many points as possible and then heads to the finish line or table to end the game. The team must get to the finish line or table before the game time is over or else they loose half of their points. A warning whistle will be blown at 40 seconds, points are still accumulated up to the 50 second whistle. All obstacles may be taken twice for points except for the A-frame. The A-frame has a special value but can not be taken back to back. The A-frame doubles all points collected up to that point. There is no limit on the number of times the A-frame can be taken

BEAT THE CLOCK: The objective of the game is for the team to perform all the obstacles on the clock before the time expires. The game starts with the dog performing the obstacle at the center of the clock face and a quarter of the obstacles on the course (#1-3). The dog then performs the center obstacle again then moves to the next quarter of the clock (#4-6). This pattern continues till all obstacles are completed (12) the dog is then directed to the finish line or table to stop the clock. If an obstacle is faulted the dog must then do the center obstacle again and reattempt that quarter of the clock before he can continue to the rest of the clock.

PINBALL WIZARD: This is a point accumulation game. The course begins on a designated start obstacle. From there, the team must accumulate a minimum number of points as determined by the judge before activating the trigger obstacle. Once the trigger has been activated, the team may complete the bonus, a series of obstacles designated by the judge. Completing the bonus will triple the accumulated points. The bonus may be repeated by resetting the trigger obstacle and again completing the bonus obstacles. This game is scored points then time.

Class Information

AWARDS: Ribbons will be awarded for 1st through 3rd in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs may receive placement ribbons without qualifying.

We will have toys OR TREATS for Qs

WARM-UPS: A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors. Obstacle familiarization on TDAA equipment will be offered before the first class each day

MOVE-UPS: Move ups will be accepted for dogs earning a title at a prior show up to the closing date. Move up requests must be in writing but may be sent via email. Move ups will also be accepted if a dog completes a title during the running of this trial. In such case, the move up request must be made immediately upon posting of scores for the class in which the title was earned.

A copy of your TDAA height card must accompany your trial entry or be presented at check in. If you do not have a TDAA permanent height card, your dog must be measured prior to running in the trial.

Standard Class

BEGINNER AGILITY—All dogs shall be eligible for participation in this class. There shall be no grand-fathering of titles from other organizations.

INTERMEDIATE AGILITY — Only dogs who have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

SUPERIOR AGILITY — Only dogs who have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

Games Class

GAMES I—All dogs shall be eligible for participation in this class. There shall be no grand-fathering of titles from other organizations.

GAMES II — Only dogs who have earned the Games I (TG1) shall be eligible for participation in this class.

GAMES III — Only dogs who have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a division lower than their proper height division. Dogs that run in a height division lower than their proper division will be eliminated. Provisional dogs must be measured by a judge. To figure leg to shoulder ratio: Height from the elbow to the ground ÷ height at the withers = % (ratio). If that percentage is less than 50% and meets the height requirement then the dog can jump at the next lower height.

4" jump height – restricted to dogs measuring 8" or less at the withers; or dogs with a jump height exception measuring 12" or less.

8" jump height – restricted to dogs measuring 12" or less at the withers; or dogs with a jump height exception measuring 15" or less.

12" jump height – restricted to dogs measuring 15" or less at the withers; or dogs with a jump height exception measuring 17" or less.

16" jump height – restricted to dogs measuring 17" or less at the withers.

ANY DOG WITHOUT A HEIGHT CARD WILL NEED TO BE MEASURED.

Dog Walk and A-Frame are Slatted, Teeter is not Slatted. The tunnels and chute are teacup sized.

2010 TDAA Petit Prix

The 2010 TDAA Petit Prix National Tournament will be held October 8, 9, 10, in Auburn, WA at Argus Ranch for Dogs. The Premium list and additional information will be available at WWW.K9TDAA.COM

Entries close at 6:00 pm on April 5, 2010 after which time entries cannot be cancelled, altered, or substituted.

Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.

Photocopied entries without the TDAA agreement on the back or attached are *not* acceptable. Unsigned, incomplete, or illegible entries are *not* acceptable. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee.

Bitches in season are not permitted in the trial. The club will refund all but five dollars of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such claim for refund by letter (not email) before the closing date.

How the Fast Track Move-Up Works

Titles may be grand-fathered from other organizations on a "Fast Track" basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move up from beginners to superior on the same day, if the dog qualifies first in beginners, then qualifies again in Intermediate.

Likewise, it is possible to move up from Games I to Games III by earning qualifying scores at the lower levels.

A qualifying score in the lower class is required to move up to the next higher class. The dog's owner must submit a copy of title certificates for the dog.

Please mark each of the following that apply:

Submit \$8.00 with your move-up request, and attach this form. Payment of the \$8.00 is no guarantee that your dog will qualify at the lower level (though he will have four chances at each), and is non-refundable.
