**Eligibility** – This trial is open to all dogs under 20” and over the age of 12\_ months, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog’s physical or mental performance.

**Your dog must be registered with TDAA to participate in TDAA Trials.** There is a registration form included in this premium, or you can register the first day of the trial. TDAA rules can be obtained online in the form of a PDF file at [www.k9tdaa.com](http://www.k9tdaa.com)

## **CLASS INFORMATION**

### **Standard Class**

**Beginner Agility** – All dogs shall be eligible for participation in this class.

**Intermediate Agility** - Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

**Superior Agility** – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) or Teacup Superior Agile Dog (TSAD) shall be eligible for participation in this class.

### **Games Classes**

**Games I** – All dogs shall be eligible for participation in this class.

**Games II** – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

**Games III** – Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

### **FEO (FOR EXHIBITION ONLY)**

WI-IL will not be accepting FEO runs at this trial.

### **FAST TRACK**

WI-IL will accept FAST TRACK runs at this trial.

## **GAMES**

### **Jumpers**

Jumpers courses consist only of hurdles and tunnels, with some limitations between the different venues. The dog is required to run the course in the sequence indicated by the judge. Follow the numbers. And keep the bars up.

### **Tunnelers**

This course consists of tunnels only. The handler must direct the dog to perform the obstacles in the order specified by the judge. Refusals are not faulted, and there are no jump bars to drop. All the handler has to worry about is staying on course.

### **Touch N’ Go**

This course consists of contact obstacles and tunnels only. The handler must direct the dog to perform the obstacles in the order specified by the judge. There are no refusals faulted, and no jump bars to drop. All the handler has to worry about is the dog touching the contacts and staying on course. Scoring Touch N Go is scored faults then time. The dog with the fewest faults will win. Time is a tiebreaker only

### **Box Game**

The objective of the Box Game is to run a numbered sequence while earning bonuses for several distance challenges. The distance-challenge eligible for bonus is specifically when the dog must go out of the box... with the handler staying inside the box.

### **Cha Cha**

A game that requires the dog to earn points to the beat of the Cha-cha: two slow beats (non-jump obstacles) followed by three quick beats (jumps). This is a game of strategy and precision. Cha-Cha is scored Bars (Points), Then Time.

### **Stay Out of Jail**

A simple sequencing game in which the dog is sent to jail (the table) for any performance fault. Stay Out of Jail is scored Time Only.

**JUDGE’S BRIEFING ON DAY OF TRIAL  
SUPERCEDES ANY PREVIOUS BRIEFINGS.**

## **NOTICE TO EXHIBITORS**

- \* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- \* All dogs must be on leash or crated at all times except when in the ring or when in designated areas (warm-up area). It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, **no refund of any fees will be made.**
- \* Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- \* Exhibitors are responsible for being at the ring gate when it is their turn to run.
- \* Exhibitors may wear shirts or insignia of their training group if they wish.
- \* At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- \* Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at [www.k9tdaa.com](http://www.k9tdaa.com)
- \* Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- \* **Photocopied entries without the TDAA agreement on the back are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- \* The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- \* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- \* No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of public enemy, or any other cause beyond the control of the organizing committee.
- \* Bitches in season are not permitted at the trial. The club will refund all but \$5.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a veterinarian of such claim for refund by letter.

## **Height Divisions**

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a lower than their proper height division. Dogs that run in a height division lower than their division will be eliminated. A judge must measure provisional dogs.

**2" jump height** - restricted to dogs measuring 4" or less at the withers; or dogs with a jump height exemption measuring 8" or less

**4" jump height** - restricted to dogs measuring 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less

**8" jump height** - restricted to dogs measuring 12" or less at the withers; or dogs with a jump height exemption measuring 16" or less.

**12" jump height** – restricted to dogs measuring 16" or less at the withers; or dogs with a jump height exemption measuring 20" or less.

**16" jump height** – restricted to dogs measuring 20" or less at the withers.

Special provisions are made for the dogs that are long-backed, or dogs whose depth of chest is greater than his legs length.

**E1 - Long backed dogs** – The long-backed dog would be based on the measurements of the dog from the front of the chest to the back of his rear compared to the measurement of the dog's height at the withers. As a rule of thumb, if the dog's length is 150% or greater than the height measurement, the dog would qualify for this exemption.

**E2 - Weight to length provision** (by structure, not obesity) – This exemption should be limited to certain breeds that have a propensity for weight that is greater than their height if you compare pounds to inches.

**E3 - Dogs with dwarfish legs/deep chest dogs** – This exemption is granted to dogs whose leg to shoulders height ratio is 1/3 or less of the dog's overall height. The exemption for dog's with dwarfish legs is based on the measurement of the dog's withers height, when that height is 150% or greater than the measurement of the space from the floor to chest.

**Veteran dog** is a dog at least 7 years of age. There is no special system of titling for veteran dogs.

**Handicapped Handlers:** Disabled handlers will be allowed an additional 4 seconds in Standard and Games classes using numbered courses. A copy of a disabled parking permit must be sent with the entry.

## **Lunch:**

## **Show Site:**

This trial will be held indoors on turf. Crating will be on mats.

**Exhibitors are responsible for providing a mat to put under crates and chairs to protect our surface. No crating or chairs allowed on the turf.**

A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of the new owner in any which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been made to TDAA.
