FEES

\$250 – New Judge’s Clinic – we will cover in depth the rules for standard agility and games in the TDAA; course design; practical judging; and trial administration. Price includes exam fee for judging candidates and lunch for four days.

\$175 – TDAA Judge’s Continuing Education – for current TDAA judges who need recertification or are interested in continuing education. Price includes exam fee and lunch for four days.

\$75 – Auditors – for auditors such as TDAA members, representatives of TDAA clubs or TDAA exhibitors interested in more information about the venue. No exam is required and no exam fee is included. No meals included. Auditors do not need to attend judges’ training Saturday and Sunday.

Thursday and Friday, July 27 & 28 – Judge’s clinic

There will be homework assignments before the clinic

Saturday and Sunday, July 29 & 30 – TDAA trial

Participants in Judges Clinic will have \$2/run rate at this trial (TDAA fee only)

PAYMENT

Full payment is required to reserve a space in the clinic. Applications will be accepted beginning May 1, 2017 and must be submitted no later than June 22, 2017.

Partial refunds may be available if you cancel before July 1, 2017. If your clinic slot can be filled TDAA will process a 50% refund. Additional participants may be accepted after the closing date on a space-available basis.

SUPPLIES:

- 1) **Course design software** – judge candidates will be expected to use Clean Run Course Designer (CRCD) software for submission of their courses at the clinic so that their course maps are easily reviewable and easily transmitted electronically. CRCD may be purchased (recommended) or may be downloaded at www.cleanrun.com in a 30-day free trial version. Judge candidates will be required to complete course design assignments, which they will submit to the clinic presenter (Bud Houston) prior to the clinic.
- 2) **Courses** – judge candidates will receive course design homework to bring to the clinic. These must be completed prior to the first day of the clinic.
- 3) **TDAA Rules Book** – a copy of the TDAA rules current at the time of the clinic can be downloaded and printed from the TDAA website www.k9tdaa.com. All participants should review a rulebook prior to the first day of the clinic and bring a copy of the rulebook.
- 4) **Measuring Wheel** – judge candidates can generally borrow a measuring wheel for use during the clinic, but may choose to buy one of their own.
- 5) **Personal Computer** – Optional – you may bring a laptop personal computer; or, at a minimum, bring course design homework on a thumb-drive.
