1. Take exit #27/OR-99/South Medford towards\ Barnett Road\Bear left onto Belknap Rd. 0.2 mi/380 m
2. Turn right onto E Barnett Rd. 0.7 mi/1.2 km
3. Turn right onto Black Oak Dr. 0.2 mi/257 m
4. School is on your right, wind around to your right to the Football Field, there's a parking lot at the field.

ENTRIES & CLOSING DATE: Your entry must be RECEIVED by **August 30, 2109** To be accepted, entries must be complete, signed (by parent or legal guardian if handler is a minor), received by the closing date, and accompanied by the correct fees made payable to **RCA** You must file a separate entry form for each dog entered (i.e., only one dog per form).

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee. A refund of all but \$5.00 will be given for bitches in season. A letter from your veterinarian is required by the first day of the Trial.
- All fees must be paid in US funds. There will be a Returned Check Fee of \$25.00 for returned checks.
- In the event of withdrawal from the event, checks will NOT be returned. All unused checks will be destroyed.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- All dogs must be on leash at all times except when using the warm-up area or in the agility ring.
- No entry fee will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee.
- Obstacles shall meet the specifications for obstacles in the current edition of the Regulations for Agility Trials.
- Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the Trial.
- Exhibitors must clean up after their dogs at the hotel and at the Trial Site.
- Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. Exhibitors may wear shirts or insignias of their training group, if they wish.
- Choke collars, pinch collars, electric and dummy electric collars are PROHIBITED.

Obstacle Familiarization - obstacle familiarization will be held Saturday and Sunday morning 30 minutes prior to judging for dogs.

Warm-ups - a warm-up area, consisting of a regulation agility jump, shall be provided for all Exhibitors.

Show site – the trial will be held on the Football field of St. Mary's school.

Eligibility - this trial is open to all dogs **20-inches** and under at the withers that are over the age of 12 months, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Move-Ups - Move-ups will be accepted for dogs earning a title at a prior show up to the closing date. Move-up requests must be in writing but may be sent via e-mail. Move-ups will also be accepted if a dog completes a title during the running of this trial. In such case, the Move-Up request must be made immediately upon posting of scores for the class in which the title was earned. "Move-up Request Form" is set out later in premium and available on the Secretary's Table at show.

AWARDS: Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying Score. Fast-Track dogs **are not** eligible for awards in classes through which they Fast-Track. FEO (For Exhibition Only) will be offered.

Judging Times: Judging will start at **9:00 a.m. each day**. Site will be open at 7:30 a.m.

CLASS INFORMATION

Games Classes

Games I - All dogs shall be eligible for participation in this class. There shall be no grand-fathering of titles from other organizations.

Games II - Only dogs who have earned the Games I (TG1) shall be eligible for participation in this class.

Games III - Only dogs who have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

Games:

April's Fool

April's Fool is a standard course that includes a bit of a practical joke/trick. An obstacle will be withdrawn from the numbered course after the walkthrough and must be omitted by the dog and handler when the course is run. This game *might* be played as a serious game of competition; but is more appropriate as a fun game for a club picnic. *April's Fool* is scored Time, Plus Faults. ER5

Snooklers

Snooklers is a point accumulation game with elements of both Snooker and Gamblers. Like Snooker, there is an opening and a closing sequence. Rather than the traditional "red hurdle" the "reds" are modest distance challenges. Otherwise the game works just like Snooker. *Snooklers* is scored Points, Then Time. ER2

Quidditch

The objective of *Quidditch* is to perform three sequences and attempt to earn a bonus (the *Beater*) after each. The point values for each of the sequences are 15, 20, and 25 points respectively. Each sequence can be successfully completed only once. The sequences can be taken in any order. Quidditch is scored points then time. ER2

Helter Skelter

Helter Skelter is a game of speed and skill, played on a numbered course consisting of obstacles arranged in a spiral that builds speed. *Helter Skelter* is scored Time, Plus Faults. ER5

Be sure to check your records and let me know if you are close to earning a Championship of any type. We want to make sure we have enough ribbons so that we can celebrate with you.

JUMP HEIGHTS

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a division lower than their proper height division. Dogs that run in a height division lower than their proper division will be eliminated. Provisional dogs must be measured by a judge. To figure leg to shoulder ratio: Height from the elbow to the ground ÷ height at the withers = % (ratio). If that percentage is less than 50% and meets the height requirement then the dog can jump at the next lower height.

- 4" for dogs 8" or less at the withers, or dogs with a jump height exemption measuring 12" or less
- 8" for dogs 12" or less at the withers, or dogs with a jump height exemption of 16" or less.
- 12" for dogs 16" or less at the withers, or dogs with a jump height exemption of 20" or less
- 16" for dogs 20" or less at the withers. Dogs 20" or less can now compete

JUMP HEIGHT EXEMPT DOGS WILL PLACE WITH DOGS IN THE HEIGHT CLASS IN WHICH THEY MEASURE AT THE WITHERS. If handler chooses to jump the dog at a higher jump height than dog measures into that dog will place with the higher jump height class.

ALL DOGS WITHOUT A PERMANENT HEIGHT CARD MUST BE MEASURED PRIOR TO THE FIRST DAY OF COMPETING AT THIS TRIAL. ARRIVE EARLY ENOUGH TO ACCOMMODATE MEASURING.

Disabled Handlers: A time exemption will be granted to disabled handlers amounting to 4 seconds in Standard course times and in qualifying course times for Games classes. Proof of disability shall be a copy of the handler's disability parking tag or other official documentation, which must be included with the entry or presented at check-in at the trial.

Entries

Entries close August 30, 2019 after which time entries cannot be accepted, canceled, altered or substituted. Day of Event Entries **WILL BE** accepted **up and until 8:15 a.m.** each morning, for \$12.00 per run. TDAA Dog Registration Numbers may be applied for at the event so that your dog can participate in this trial.

Entries will not be accepted without fees. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry forms. One dog per entry form.

Photocopied entries, without the signed TDAA Agreement attached are NOT acceptable. Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the Trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$25.00 service charge for any returned check(s). Subsequent returned check(s) from the same Exhibitor may result in their being put on a CASH ONLY basis.

I/We agree to hold the TDAA, TDAA approved judge and Rogue Canine Agility harmless from any legal claim resulting from said Judge's action under the TDAA Rules, Regulations and Guidelines. I/We agree that RCA has the right to refuse entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Agility Trial and of the opportunity to have the dog judged, I/We agree to hold harmless the directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or things by the act of this dog while in or upon the show/trial premises or grounds or near any entrance thereto, and I/We personally assume all responsibility and liability for any such claim, and I/We further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

Instructions

A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of the new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been made to TDAA.
