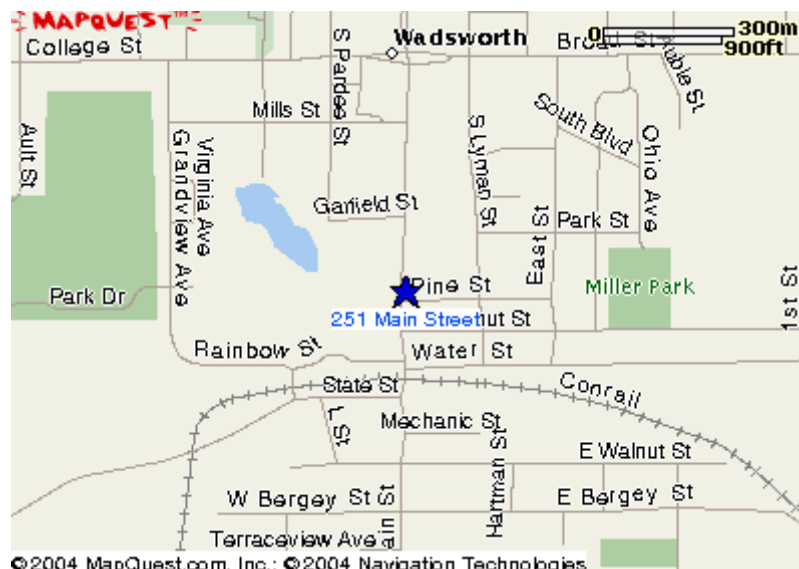

## Trial Site and Region



### Wadsworth, Ohio

**If you are coming from I-71 - get off at the Rt. 18 exit, and go East.  
If you are coming from I-77 - get off at the Rt. 18 exit, and go West.  
Take Route 18 to Route 94 (Ridge Rd.) Go south on Route 94.  
This will become Ridge Road, and later, Main Street**

**Travel south on Rt. 94, until you get to Wadsworth.  
Go straight through town in Wadsworth, staying on Rt. 94.  
Our building is on the left, about 2 blocks south of the old town square.  
It is a big brick factory - the address is 257 Main St.  
(Possibly the address is not displayed anywhere.)  
The first street at the south end of the building is Pine St.  
Turn left onto Pine, and go approximately 150 feet,  
Turn left into a small gravel driveway, next to a gray house.  
It is the first drive on the left.  
Please park behind the building in the gravel lot (not the paved lot) and  
look for our marked entrance.**

## Notice to Exhibitors

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site.

In such case, no refund of any fees paid will be made.

Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Exhibitors may wear shirts or insignia of their training group if they wish.

At the handler's option, the dog may wear a flat (buckle or quick release) collar. Choke collars, pinch collars, electric and dummy electric collars are prohibited.

Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

**ELIGIBILITY:** This event is open to all registered TDAA dogs 20 inches or under, over the age of 12 months, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance.

**ENTRIES CLOSE** 6:00 p.m., August 31, 2019. Day of show entries will be accepted with an additional handling fee of \$3.00 per class.

**This trial will be held indoors.**

Show hours are 8:00 am to 5:00 pm

**Games Classes**

**Weakest Link**– The objective of The Weakest Link is to score as many points as possible in the allotted time. Only “banked” points will count toward the final score. Points are banked when the dog gets on the obstacle specified by the judge as the “banking” obstacle. The dog and handler team have 60 seconds to accumulate the best score possible.

**Tire Jacks**- is a game of strategy and skill, played like the children’s game of jacks. The performance of the tire jump is the bounce of the ball. All other obstacles on the course are jacks and have specific point values. After the bounce the team begins with “onsies” then “twosies”... and all the way through “sevensies”, time permitting. Tire Jacks is scored Points, then time.

**Touch N Go**- is a numbered course consisting of tunnels and contact obstacles only! Touch ‘n Go is scored Faults, Then Time.

**Fullhouse**– is a game of timing in which the dog is obligated to collect the elements of the full house, earn as many other points as possible, and end time without losing points on a time penalty. Full House is scored Points, Less Penalty, then Time.

**Jumpers**- is a favorite game in the dog agility world. Courses are made up of jumps and tunnels only, so the play is fast and furious. Follow the numbers and keep the bars up. Jumpers is scored either Time, Plus Faults or Faults, Then Time.

**Judge's briefing on the day of trial supersedes any previous briefings.**

Effective January 1, 2014

**AWARDS:** Ribbons will be awarded for 1st through 3rd in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs may receive placement ribbons without qualifying.

**WARM-UPS:** A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors. Obstacle familiarization on TDAA equipment will be offered before the first class.

**MOVE-UPS:** Move ups will be accepted for dogs earning a title at a prior show up to the closing date. Move up requests must be in writing but may be sent via email. Move ups will also be accepted if a dog completes a title during the running of this trial. In such case, the move up request must be made immediately upon posting of scores for the class in which the title was earned.

## Class Information

### Standard Class

**BEGINNER AGILITY**—All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations. (However, see rules for fast track titling.)

**INTERMEDIATE AGILITY** — Only dogs who have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

**SUPERIOR AGILITY** — Only dogs who have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

### Games Class

**GAMES I**—All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations. (However, see rules for fast track titling.)

**GAMES II** — Only dogs who have earned the Games I (TG1) shall be eligible for participation in this class.

**GAMES III** — Only dogs who have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

### Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a division lower than their proper height division. Dogs that run in a height division lower than their proper division will be eliminated. Provisional dogs must be measured by a judge. To figure leg to shoulder ratio: Height from the elbow to the ground ÷ height at the withers = % (ratio). If that percentage is less than 50% and meets the height requirement then the dog can jump at the next lower height.

**4" jump height** – Restricted to dogs measuring 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less.

**8" jump height** – Restricted to dogs measuring 12" or less at the withers; or dogs with a jump height exemption measuring 16" or less.

**12" jump height** – Restricted to dogs measuring 16" or less at the withers; or dogs with a jump height exemption measuring 20" or less.

**16" jump height** – Restricted to dogs measuring 20" or less at the withers.

## Entries

Entries close at 6:00 pm on August 31, 2019, after which time entries cannot be cancelled, altered, or substituted.

Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.

Photocopied entries without the TDAA agreement on the back or attached are *not* acceptable. Unsigned, incomplete, or illegible entries are *not* acceptable. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee.

Bitches in season are not permitted in the trial. The club will refund all but five dollars of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such claim for refund by letter (not email) before the closing date.

## How the Fast Track Move-Up Works

Titles may be grandfathered from other organizations on a “Fast Track” basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move up from Beginners to Superior on the same day, if the dog qualifies first in Beginners, and then qualifies again in Intermediate.

A qualifying score in the lower class is required to move up to the next higher class. The dog’s owner must submit a copy of title certificates for the dog.

Please mark each of the following that apply:

Move up from Games I to:  Games II  Games III

Submit \$8.00 with your move-up request, and attach this form. Payment of the \$8.00 is no guarantee that your dog will qualify at the lower level (though he will have four chances at each), and is non-refundable.



**Agreement**

I (We) acknowledge that the “Teacup Dogs Agility Association Rules & Regulations” have been made available to me (us), and that I am (we are) familiar with their contents. I (We) agree to hold the TDAA and any TDAA approved judge harmless from any legal claim resulting from said judge’s action under the TDAA Rules, Regulations and Guidelines. I (We) agree that the club holding the Agility Trial has the right to refuse entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Agility Trial and of the opportunity to have the dog judged, I (we) agree to hold harmless the directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or things by the act of this dog while in or upon the show/trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I(we) further agree to hold the aforementioned parties harmless from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (We) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time arising out of or in consequence of my(our) participation in this Agility Trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I certify than I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above in consideration of the acceptance of this entry. I (We) agree to abide by the rules and regulations of the Teacup Dogs Agility Association in the premium list for this agility trial, or both, and further agree to be bound by the “Agreement” printed above. I (We) certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and agreement.
