### **Lunch:**

### **Notice to Exhibitors:**

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and are able to perform all obstacles safely.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the Trial site. In such case, no refund of any fees paid will be made.

Handlers are not allowed to use whistles or other instruments or devices.

Food and toys are allowed in the ring, in accordance with TDAA Rules and Regulations.

Exhibitors are responsible for being at the ring gate when it is their turn to run. Exhibitors may wear shirts or insignia of their training group if they wish.

At the handler's option, the dog may wear a flat (buckle or quick release) collar. Choke collars, pinch collars, electric and dummy electric collars are prohibited. Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

We request that exhibitors bring some kind of floor covering to be placed under your dog's crate, chair, etc.

**Handlers must pick up after their dogs at the trial site.**

### Eligibility:

This trial is open to all dogs measuring 20 inches or less at the withers over the age of 12 months, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance.

### Your dog must be registered with TDAA to participate in TDAA Trials.

**Disabled Handler Exemption:** Handlers who have been given disability status by their home state will be allowed an additional 4 seconds in standard course time for Standard courses and an additional 4 seconds in qualifying course time for Games classes. This is in addition to any additional time awarded through the Veteran Dog exemption. A copy of the handler's disabled parking permit must be sent with the entry or presented 30 minutes prior to the start of the trial (8:30 a.m.).

**Call, Direct and Send:** *Call, Direct and Send (CDS)* is a numbered course that requires the team to solve three distance challenges: Call, Direct, and Send. CDS is scored Time, Plus Faults, Less Bonus. ER7

**Rekoons:** *Rekoons* is Snooker played backwards. Rekoons is a two-part game. The opening sequence in Rekoons is to perform the numerical sequence 7 – 2. After completing #7 obstacle (or faulting an obstacle in the opening) the dog is directed to collect points by doing different combinations of red (jumps) and obstacles. *Rekoons* is scored Points, Then Time. ER2

**Full House:** *Full House* is a game of timing in which the dog is obligated to collect the elements of the full house, earn as many other points as possible, and end time without losing points on a time penalty. *Full House* is scored Points, Less Penalty, Then Time. ER6

**The judge's briefing, given 15 minutes prior to the start of judging, supersedes these descriptions of how to play any game.**

**Awards:** Ribbons will be awarded for 1<sup>st</sup> through 3<sup>rd</sup> in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying

Score. Dogs may receive placement ribbons without qualifying. New title, TAM, TMAG and TACH ribbons are available.

**Warm-Ups:** A warm up area consisting of at least an agility jump will be provided for all exhibitors. Obstacle familiarization on TDAA equipment will be offered 30 minutes before the first class each day. One dog in the ring at a time.

**Move-Ups:** Move-ups will be accepted for dogs earning a title at a prior show up to the closing date. Move up requests must be in writing but may be sent via email at least 48 hours prior to the trial. Move ups will also be accepted if a dog completes a title during the running of this trial. In such case, the move up request must be made immediately upon posting of scores for the class in which the title was earned. Move-ups will be accepted each day from event to event.

### Obstacles to be Used:

Rubberized A-frame (8' slat-less)      Open (pipe) Tunnel (16")

Rubberized Dog walk (8' with slats)      Teeter (8')

Weave Poles (21" centers)      Table (30"x30")

Single and Winged Jumps      Tire Jump (16")

All obstacles meet TDAA equipment size requirements

### Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. Judge will be available to measure dogs who have not been measured. At the handler's option, dogs may be entered at any jump height desired; however, the scoring height continues to be the dog's measured jump height. Dogs jumping at a height other than their measured height will earn qualifying legs and all TDAA titles.

#### Divisions:

- **2" jump height** for dogs with a jump height exemption measuring 8" or less.
- **4" jump height** for dogs 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less.
- **8" jump height** for dogs 12" or less at the withers; or dogs with a jump height exemption measuring 16" or less.
- **12" jump height** for dogs 16" or less at the withers; or dogs with a jump height exemption measuring 20" or less.
- **16" jump height** for dogs 20" or less at the withers.

### **Jump Height Exemptions**

Special provisions are made for dogs that are long-backed, have a weight-to-height exemption, or who have dwarfish legs (see [www.k9tdaa.com](http://www.k9tdaa.com), Rules, Sec. 3.5.5 for description of height exemptions). A jump height exemption (next lower height) will also be granted to veteran dogs (dogs of at least 7 years of age). You may subtract one height for Veteran status and one for Body Exemption from Measured Jump Height. Some handlers prefer to jump at other heights, as allowed under the TDAA Rules and Regulations.

### **Standard Class**

**Beginner Agility** – All dogs shall be eligible for participation in this class. No grandfathering of titles from other organizations is allowed.

**Intermediate Agility** – Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

**Superior Agility** – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

### **Games Class**

**Games I** – All dogs shall be eligible for participation in this class. No grandfathering of titles from other organizations is allowed.

**Games II** – Only dogs that have earned the Games I (TGI) shall be eligible for participation in this class.

**Games III** – Only dogs that have earned the Games II (TG2) shall be eligible for participation in this class.

**FEO**– For Exhibition Only runs are open to any TDAA-registered dog in any class. FEO dogs will run last in their jump height and may run on lead. FEO teams receive 1.5 times the SCT for their level. FEO runs do not count toward TDAA titles or certificates and no ribbons are awarded.

**Entries:** Entries will be allowed on the day of the trial, before judging begins. Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry forms, one dog per entry form. Photocopied entries without the TDAA agreement on the back or attached are NOT acceptable. Unsigned, incomplete, or illegible entries are NOT acceptable and cannot be entered in the Trial. Credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

The Trial Secretary will add a \$25.00 service charge for returned checks. Subsequent returned checks from the same exhibitor may result in them being put on a CASH ONLY basis. Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Bitches in season are not permitted in the trial. The club will refund all but ten dollars of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such a claim for refund before the Friday preceding the trial.

**Day of event entries must be given to the secretary no later than 8:00 a.m.** TDAA Dog Registration Numbers may be applied for at the event so that your dog can participate in this trial.

### **CLASS INFORMATION for Fall Fun Run TDAA Special Event**

The Fall Fun Run is a part of this trial. When you register, please indicate whether you wish to compete in the Fall Fun Run so we have an accurate understanding of the participants and can prepare the runs and the trial results correctly. It is not necessary to compete in the Fall Fun Run if you do not wish to do so. All qualifying runs, regardless of whether you are competing in the Fall Fun Run, will count toward regular TDAA titles.

Those who wish to participate in the Fall Fun Run need to know that there are two aspects to the Rules that are different for this event. The Fall Fun Run is a special event, like the Petit Prix. As a result, dogs are required to jump at their measured jump height as adjusted for any exemptions to which they are entitled. Also, no food or toys are allowed to be used in the ring.

Beginner and Intermediate dogs may run in the Superior and Games III levels to earn legs at the Fall Fun Run at their respective level.

The scores for Beginner and Intermediate level dogs will only count toward the Fall Fun Run classes for this event at the Superior and Games III levels.

The Fall Fun Run will be run at several clubs through November 21. After all of the clubs have held their trials, the results will be compiled and a Champion and Reserve Champion will be identified for all five scoring heights. Please note that there will be one Champion and Reserve Champion per jump height will be awarded for the Fall Fun Run nationwide.

TDAA will provide the overall Champion and Reserve Champion awards. TDAA will also provide a participation rosette for each handler. \*\*\*In 2022 the TDAA Petit Prix will be presented by Cloud Nine Training School for Dogs in Maple Grove, Minnesota on July 28th-31st. Kim and Dennis Vogel are our gracious hosts for this event.\*\*\*

### How the Fast Track Move-Up Works

Titles may be grandfathered from other organizations on a "Fast Track" basis. It is possible to move up from Beginner to Superior on the same day, if the dog qualifies first in Beginner, and then qualifies again in Intermediate. Likewise, it is possible to move up from Games I to Games III by qualifying at each of the lower levels. A qualifying score in the lower class is required to move up to the next higher class.
