Certification Permission has been granted by the Teacup Dogs Agility Association for the holding of this event under Teacup Dog Agility Association Rules and Regulations.

TRIAL INFORMATION

This trial will be held indoors on rubber over padding. The following is a list of obstacles to be used. Contacts have rubber coating. 2" jumps will be obtained by crossing bars on the 4" jump cups.

*A-frame (6' 8" slatless) Closed (Collapsed) Tunnel Tire Jump (16") Dog walk (8' slatless ramps) Table (30" by 30")
Open (Pipe) Tunnel (16") Single & winged jumps Teeter (8' slatless, 12" wide) Weave poles (22" centers)*

A warm up area with TDAA equipment provided for all exhibitors. Obstacle familiarization is available each morning prior to judging.

Awards: Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying score. Dogs may receive placement ribbons without qualifying. Fast track dogs will only get Qualifying ribbons at the Beginners/Games I and Intermediate/Games II levels.

PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS All dogs must be kept on leash except in designated areas

Eligibility: This trial is open to all dogs under 20" and over the age of 12 months, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Your dog must be registered with TDAA to participate in TDAA Trials. There is a registration form included in this premium, or you can register the first day of the trial. TDAA rules can be obtained online at www.k9tdaa.com

GAMES DESCRIPTIONS *Call or email if you have any questions about these games!*

12-Tone Row – is a dog's-choice game. Accumulate as many points as possible in 60 seconds by performing only 12 obstacles, and the final obstacle must be the weaves. No faults for missed weaves, but weaves must be completed. Scored Points, Less Faults, then time.

Tunnelers – is a numbered course consisting only of tunnels. Scored Time, Plus Faults.

Heinz 57 – is a dog's choice game. Teams must collect exactly 57 points. Obstacles on course have varying point values and a doubling obstacle is available. Scored Points, then Time.

Strategic Pairs – is a pairs game, with a course laid out that the team must run. Each member of the team must do at least one segment, more if desired or necessary. Where the teams switch dogs is up to the team.

Jackpot – is a two-part game. The first part consists of the dog working to accumulate at least the minimum required points for their level. In the second part, the dog must be directed to attempt a distance challenge earning points for each successfully completed. Jackpot is scored Points, then Time.

CLASS INFORMATION

Standard Agility Class

Beginner All dogs shall be eligible for participation in this class.
Intermediate Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.
Superior Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

Games Classes

Games I All dogs shall be eligible for participation in this class.
Games II Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.
Games III Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

FEO (FOR EXHIBITION ONLY) – Games & Standard Classes

TDAA offers FEO runs (at the option of the host club), open to any TDAA registered dog in any class. FEO dogs will run last at their jump heights. They may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. Maximum time of 1.5 of the SCT, cannot repeat any obstacles, and no training in the ring.

Fast Track Move-Ups: Titles may be grandfathered from other organizations on a "Fast Track" basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move from Beginner to Superior on the same day if the dog qualifies first in Beginner and again in Intermediate. Likewise, a dog may move from Games I to Games III by qualifying at each of the lower two levels. A qualifying score in the lower class is required to move up to the next higher class. The dog's owner must submit a copy of title certificates for the dog. Please mark each that apply and submit \$8.00 with your entry with the FAST TRACK portion completed. Payment of the \$8.00 is not a guarantee that your dog will qualify at the lower level and is non-refundable. This fee must be paid for this trial even if a Fast Track fee has been paid in the past.

HEIGHT DIVISIONS - See www.k9tdaa.com for updates to Rules and height divisions!

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division (and scored in that higher height division) but not in a lower height than their proper height division. Dogs that run in a height division lower than their division will be eliminated. A judge must measure provisional dogs.

Veteran dog - Granted to dogs at least 7 years of age. There is no special system of titling for veteran dogs.

Also, special provisions are made for the dogs that are long-backed, or dogs whose depth of chest is greater than his legs length.

Long backed dogs – Based on the measurements of the dog from the front of the chest to the back of his rear compared to the measurement of the dog's height at the withers. As a rule of thumb, if the dog's length is 150% or greater than the height measurement, the dog would qualify for this exemption.

Weight to length provision (by structure, not obesity) – Should be limited to certain breeds that have a propensity for weight that is greater than their height if you compare pounds to inches.

Dogs with dwarfish legs/deep chest dogs – Granted to dogs whose leg to shoulders height ratio is 1/3 or less of the dog's overall height. Dwarfish legs in based on the measurement of the dog's withers height, when that height is 150% or greater than the measurement of the space from the floor to chest

**Please consult your jump height card/email to confirm the correct jump height to enter.
If you do not have a TDAA height card/email your dog must be measured at this trial.**

Disabled Handlers – A time exemption will be granted to disabled handlers amounting to 4 seconds for Standard course times and 4 seconds for qualifying course times for games class. The proof of the disability shall be the handler's disability parking tag or other documentation. There will be no special system of titling for disabled handlers.

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * All dogs must be on leash or crated at all times except when in the ring or when in designated areas, being the warm-up area and the designated off leash area. It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial Committee, be asked to leave the trial site. In such case, no refund of any fees will be made.
- * Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- * Exhibitors are responsible for being at the ring gate when it is their turn to run.
- * Exhibitors may wear shirts or insignia of their training group if they wish.
- * At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- * Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at www.k9tdaa.com
- * Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- * **Photocopied entries without the TDAA agreement are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- * The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- * No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.
- * Bitches in season are not permitted in the trial. Full refund for bitches in heat if notification is sent to the Trial Secretary in writing (E-mail OK) no later than the Friday before the trial.
