### Colors

Colors is a sequencing game. The handler has a choice of running any one of two or three short courses that are woven together on the field. Colors is scored Faults, Then Time.

### Full House

Full House is a game of timing in which the dog is obligated to collect the elements of the full house, earn as many other points as possible, and end time without losing points on a time penalty. Full House is scored Points, Less Penalty, Then Time

### Jumpers

Jumpers is a favorite game in the dog agility world. Courses are made up of jumps and tunnels only, so the play is fast and furious. Follow the numbers and keep the bars up.

Obstacle Familiarization will be provided on Saturday morning 30 minutes prior to judging for dogs and handlers who have not previously seen TDAA equipment.

**AWARDS:** Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying score. Dogs may receive placement ribbons without qualifying. Fast track dogs will only get Qualifying ribbons at the Beginner/Games I and Intermediate/Games II levels.

**Fast Track Move-Ups:** Titles may be grandfathered from other organizations on a "Fast Track" basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move up from Beginner to Superior or from Games I to Games III on the same day. The dog must qualify first in Beginner and again in Intermediate or Games I and Games II. A qualifying score in the lower class is required to move up to the next higher class. The dog's owner must submit a copy of title certificates for the dog. **Please mark each that apply and submit \$8.00 with this FAST TRACK Move-Up Request form. Payment of the \$8.00 is not a guarantee that your dog will qualify at the lower level and is non-refundable. The Fast Track fee must be paid for this trial even if it was paid for previous trials.**

Disabled Handlers – Disabled handlers will be given additional time amounting to 4 seconds in standard course time for Standard classes and 4 seconds in qualifying course time for Games classes. A copy of the handler's disabled parking tag or other official documentation shall be sent with the entry or provided at check-in as proof of disability.

## **NOTICE TO EXHIBITORS**

\* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

\* All dogs must be on leash or crated at all times except when in the ring or when in designated areas, being the warm-up area and the designated off leash area. It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial Committee, be asked to leave the trial site.

\* In such case, no refund of any fees will be made.

\* Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.

\* Exhibitors are responsible for being at the ring gate when it is their turn to run.

\* Exhibitors may wear shirts or insignia of their training group if they wish.

\* At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.

\* Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at [www.k9tdaa.com](http://www.k9tdaa.com)

\* Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.

\* **Photocopied entries without the TDAA agreement on the back are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

\* The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

\* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

\* No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.

\* Bitches in season are not permitted at the trial. The club will refund all but \$5.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such claim for refund by letter (not email) before January 6, 2012.

### **Height Divisions**

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a lower than their proper height division. Dogs that run in a height division lower than their division will be eliminated. A judge must measure provisional dogs.

**4" jump height** - restricted to dogs measuring 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less

**8" jump height** - restricted to dogs measuring 12" or less at the withers; or dogs with a jump height exemption measuring 15" or less.

**12" jump height** – restricted to dogs measuring 15" or less at the withers; or dogs with a jump height exemption measuring 17" or less.

**16" jump height** – restricted to dogs measuring 17" or less at the withers.

Special provisions are made for the dogs that are long-backed, or dogs whose depth of chest is greater than his legs length.

**E1 - Long backed dogs** – The long-backed dog would be based on the measurements of the dog from the front of the chest to the back of his rear compared to the measurement of the dog's height at the withers. As a rule of thumb, if the dog's length is 150% or greater than the height measurement, the dog would qualify for this exemption.

**E2 - Weight to length provision** (by structure, not obesity) – This exemption should be limited to certain breeds that have a propensity for weight that is greater than their height if you compare pounds to inches.

**E 3 - Dogs with dwarfish legs/deep chest dogs** – This exemption is granted to dogs

whose leg to shoulders height ratio is 1/3 or less of the dog's overall height. The exemption for dog's with dwarfish legs is based on the measurement of the dog's withers height, when that height is 150% or greater than the measurement of the space from the floor to chest veteran dog is a dog at least 7 years of age. There is no special system of titling for veteran dogs.

A dog also may be given a waiver to jump at a lower height even though he does not meet any of the criteria for a jump height exemption. A waiver will be given to a dog for extraordinary circumstance. Dogs given a waiver to a lower jump height will be able to earn qualifying legs and all TDAA titles.

**A copy of your TDAA height card must accompany your trial application or be presented at check-in. If you do not have a TDAA height card your dog must be measured.**

**Beginner Agility** – All dogs shall be eligible for participation in this class.  
**Intermediate Agility** - Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.  
**Superior Agility** – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

**Games Classes**

**Games I** – All dogs shall be eligible for participation in this class.  
**Games II** – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.  
**Games III** – Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

**FEO (FOR EXHIBITION ONLY)**

TDAA now offers FEO runs. They are open to any TDAA registered dog in any class. These are offered at the option of the local/host club. FEO dogs will run last at their jump heights. They may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. FEO will have a maximum time of 1.5 times of the SCT. FEO cannot repeat any obstacles, no training in the ring.
