Obstacle Familiarization will be provided 30 minutes prior to judging.

AWARDS: Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying score. Dogs may receive placement ribbons without qualifying. Fast track dogs will only get Qualifying ribbons at the Beginner/Games I and Intermediate/Games II levels.

PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE.

All dogs must be kept on leash except in designated areas.

GAMES

Connect the Dots is a dog's choice point accumulation game. The objective is to handle the dog from dot to dot (the contact obstacles) scoring points on all other obstacles in between. Points for the "in between" obstacles are always at risk, as they'll be lost in case of any fault since the last "dot". Connect the Dots is scored Points, Then Time. ER2

Jumpers is a favorite game in the dog agility world. Courses are made up of jumps and tunnels only, so the play is fast and furious. Follow the numbers and keep the bars up. Jumpers is scored either Time, Plus Faults. ER5

Eligibility – This trial is open to all dogs 20" or less and over the age of 12 months, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Your dog must be registered with TDAA to participate in TDAA Trials. There is a registration form included in this premium, or you can register the day of the trial. TDAA rules can be obtained online in the form of a PDF file at www.k9tdaa.com

CLASS INFORMATION

Standard Class

Beginner Agility – All dogs shall be eligible for participation in this class.

Intermediate Agility - Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

Superior Agility – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

Games Classes

Games I – All dogs shall be eligible for participation in this class.

Games II – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

Games III – Only dogs that have earned the Games II (TG2) shall be eligible for participation in this class.

FEO (FOR EXHIBITION ONLY)

TDAA offers FEO runs. They are open to any TDAA registered dog in any class. These are offered at the option of the local/host club. FEO dogs will run last at their jump heights. They may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. FEO will have a maximum time of 1.5 of the SCT. FEO cannot repeat any obstacles, no training in the ring.

Pre-entries close on the Thursday prior to the trial date Day of Trial Entries will be accepted before 6:30 PM for an additional fee. See below.

Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered at any jump height desired; however, the scoring height continues to be the dog's measured jump height. Dogs jumping at a height other than their measured height will earn qualifying legs and all TDAA titles. A judge must measure provisional dogs.

4" score height - restricted to dogs measuring 8" or less at the withers.

8" score height - restricted to dogs measuring 12" or less at the withers.

12" score height – restricted to dogs measuring 16" or less at the withers.

16" score height – restricted to dogs measuring 20" or less at the withers.

The TDAA will allow a dog's handler/owner to choose what jump height is appropriate for that dog. That means that all jump height exemptions based on body type will go away; and jump heights will become self selecting.

Veterans dogs - Dogs of at least 7 years of age. Veteran dogs receive an extension in standard course time. 4" veterans receive an additional 4 seconds while 8", 12" and 16" veterans receive an additional 2 seconds.

Disabled Handlers - Will be granted a time exemption of 4 seconds for Standard course times and 4 seconds for Qualifying course times for games classes. Proof of disability shall be the issued disability parking tag or other documentation. There will be no special system of titling for veteran dogs or for disabled handlers.

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- All dogs must be on leash or crated at all times except when in the ring or when in designated areas, being the warm-up area and the designated off leash area. It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial Committee, be asked to leave the trial site.
- In such case, no refund of any fees will be made.
- Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- Exhibitors are responsible for being at the ring gate when it is their turn to run.
- Exhibitors may wear shirts or insignia of their training group if they wish.
- At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at www.k9tdaa.com
- Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- **Photocopied entries without the TDAA agreement on the back are NOT acceptable.** Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- The Trial Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, and act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.
- Bitches in season are not permitted at the trial. The club will refund all but \$5.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such claim for refund by letter (not email) before March 12, 2022.

Agreement

I (We) acknowledge that that "Teacup Dog Agility Association Rules & Regulations" have been made available to me (us), and that I am (we are familiar with their contents. I (We) agree to hold the TDAA and any TDAA approved judge harmless from any legal claim resulting from said judge's action under the TDAA Rules, Regulation and Guidelines. I (We) agree that the club holding the Agility Trial has the right to refuse entry for cause, which the club deems to be sufficient. In consideration of the acceptance of this entry and of the holding of the Agility Trial and of the opportunity to have the dog judged, I (we) agree to hold harmless the director, governors, officers, agents, superintendents or show secretary and the owner or lesser of the premises and any employees of the aforementioned parties from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any or thing by the act of this dog while in or upon the show/trial premises or grounds or near any entrance thereto, and I (We) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to dog, whether such loss, disappearance, theft, damage or injury, by caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person or any other cause or causes.

I (We) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time arising out of or in consequence of my (our) participation in this Agility Trial, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

Likewise, a dog may move up from Games I to Games III by qualifying at each of the lower two levels. A qualifying score in the lower class is required to move up to the next higher class. The dog's owner must submit a copy of title certificates for the dog. **Please mark each that apply and submit \$8.00 with this FAST TRACK Move-Up Request form. Payment of the \$8.00 is not a guarantee that your dog will qualify at the lower level and is non-refundable.**
