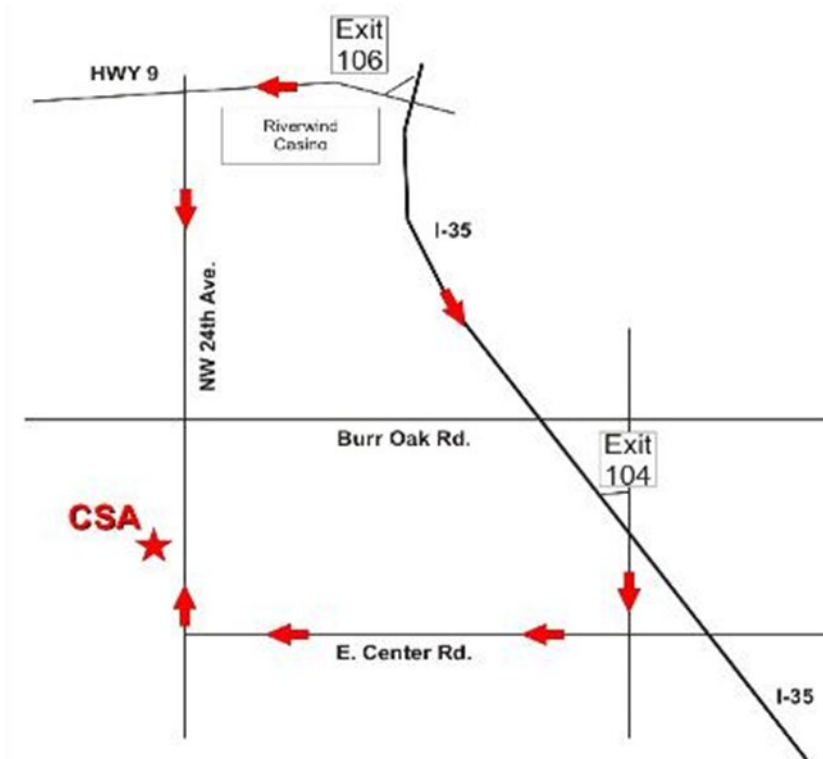
DIRECTIONS

From the North: I-35 to Exit 106 Hwy 9 West at Riverwind Casino. Go one mile toward Chickasha and turn Left onto Santa Fe (also NW 24th St) then go 2.2 miles south. The Academy is on the Right.

From the West on Hwy 9 turn Right onto Santa Fe (also NW 24th St) and follow the above directions.

From the South: Exit I-35 at Exit 104 Goldsby to W Interstate Drive to NW Main (Marcums Nursery & Libby's Cafe). Turn Right onto Center and go straight to NW 24th. Turn Right and the Academy will be on your left.

This also a good choice when coming from the North as traffic is often backed up at the Casino.



ENTRIES & CLOSING DATE: Entries will be accepted until the 50-dog limit is reached. To be accepted, entries must be complete, signed (by parent or legal guardian if handler is a minor), received by the closing date, and accompanied by the correct fees made payable to **CSA**. You must file a separate entry form for each dog entered (i.e., only one dog per form).

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee. A refund of all but \$5.00 will be given for bitches in season. A letter from your veterinarian is required by the first day of the Trial.
- All fees must be paid in US funds. There will be a Returned Check Fee of \$25.00 for returned checks.
- In the event of withdrawal from the event, checks will NOT be returned. All unused checks will be destroyed.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- All dogs must be on leash at all times except when using the warm-up area or in the agility ring.
- No entry fee will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee.
- Obstacles shall meet the specifications for obstacles in the current edition of the Regulations for Agility Trials.
- Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the Trial.
- Exhibitors must clean up after their dogs at the hotel and at the Trial Site.
- Handlers are not allowed to use whistles or other instruments or devices.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. Exhibitors may wear shirts or insignias of their training group, if they wish.
- Choke collars, pinch collars, electric and dummy electric collars are PROHIBITED.

Obstacle Familiarization - obstacle familiarization will be held Friday evening, Saturday and Sunday morning 30 minutes prior to judging for dogs. Familiarization - one time per dog.

Warm-ups - a warm-up area consisting of a regulation agility jump at a minimum (and any available agility equipment without restriction) shall be provided for all Exhibitors.

Show site – This trial is indoors, climate-controlled, and has 1-inch Martial Arts Mats.

Eligibility - this trial is open to all dogs **17-inches** and under at the withers that are over the age of 12 months, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Move-Ups - Move-ups will be accepted for dogs earning a title at a prior show up to the closing date. Move-up requests must be in writing but may be sent via e-mail. Move-ups will also be accepted if a dog completes a title during the running of this Trial. In such case, the Move-Up request must be made immediately upon posting of scores for the class in which the title was earned. "Move-up Request Form" is set out later in premium and available on the Secretary's Table at show.

AWARDS: Ribbons will be awarded for 1st through 3rd in each jump height of each class by CSA on Sat & TTAC on Sun. Qualifying ribbons will be awarded to all dogs receiving a Qualifying Score. FEO (For Exhibition Only) will be offered.

CLASS INFORMATION

Standard Class

Beginner Agility - All dogs shall be eligible for participation in this class. Dogs with higher titles from other organizations may *fast track through* Beginner Agility. An eligible dog may move up after one qualifying score.

Intermediate Agility - Only dogs who have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class. Dogs with higher titles from other organizations may *fast track through* Intermediate Agility. An eligible dog may move up after one qualifying score.

Superior Agility - Only dogs who have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class. Dogs who have earned the Teacup Superior Agile Dog (TSAD) are also eligible for this class.

Games Classes

Games I - All dogs shall be eligible for participation in this class. Dogs with higher titles from other organizations may *fast track through* Games I. An eligible dog may move up after one qualifying score.

Games II - Only dogs who have earned the Games I (TG1) shall be eligible for participation in this class. Dogs with higher titles from other organizations may *fast track through* Games I. An eligible dog may move up after one qualifying score.

Games III - Only dogs who have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

Games

Spaghetti Junction – Friday

The object of the Spaghetti Junction is to maneuver as quickly as possible through multiple sets of obstacles that are arranged in a star-like shape on the course. There is a "mix master" interchange of center obstacles that allow one to change directions to get from one of the sequences to another. Spaghetti Junction is scored points, then time. Time is a tie-breaker only. ER2

What's my Line – Saturday

The objective of What's My Line is to perform all of the obstacles on the field without repeating or omitting any, as quickly as possible. What's My Line is scored points, then time. Time is a tie-breaker only. ER2

Tag 10 – Saturday

The purpose of Tag 10 is to accumulate points in 10-point blocks and to accumulate as many of those 10-point sets as possible. Sixty seconds are allotted for play. Tag 10 is scored points, then time. Time is a tiebreaker only. ER2

Quidditch – Sunday

The objective of Quidditch is to perform three sequences and attempt to earn a bonus (the Beater) after each. The point values for each of the sequences are 15, 20, and 25 points respectively. Each sequence can be successfully completed only once. The sequences can be taken in any order.

Quidditch is scored points then time. Time is a tie-breaker only. ER2

Impossible Tunnel Game– Sunday

Impossible Tunnel Game is a sequence tunnel course that has to be done in correct order. Impossible Tunnel Game is scored time, plus faults. ER5

For more information on these games the *Book of Agility Games* is available on the TDAA web site; please visit: <https://k9tdaa.com>. Our Judges reserve the right to adapt any game played. Day of show rules supersede all others.

Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in any height division. Dogs that run in a height division other than their proper division will be scored with dogs of their measured height, and will receive all titles and qualifying runs.

TDAA height divisions are:

- 4" jump height: for dogs measuring 8" or less at the withers;
- 8" jump height: for dogs measuring 12" or less at the withers;
- 12" jump height: for dogs measuring 16" or less at the withers;
- 16" jump height: for dogs measuring 20" or less at the withers.
- 20" measured height ~ dogs measuring in excess of 20" at the withers. These dogs must compete on large equipment and will jump no higher than 16" hurdles.

ALL DOGS WITHOUT A PERMANENT HEIGHT CERTIFICATE must be measured prior to the first day of competing at this trial. Arrive early enough to accommodate measuring.

TWO MEASUREMENTS BY TDAA JUDGES are needed to show a dog in the TDAA without requiring measurement.

For Exhibition Only (FEO)

TDAA allows FEO runs open to any TDAA registered dog in any class; offered at the option of the host club. FEO dogs may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. FEO will have a maximum of 1.5 times of the SCT. FEO cannot repeat any obstacles. No training in the ring.

Disabled Handlers: A time exemption will be granted to disabled handlers amounting to 4 seconds in Standard course times and in qualifying course times for Games classes. Proof of disability shall be a copy of the handler's disability parking tag or other official documentation, which must be included with the entry or presented at check-in at the trial.

Entries

Entries close the day before the trial, after which time entries cannot be accepted, canceled, altered or substituted. Day of Event Entries WILL BE accepted up and until the start of the run, for \$13.00 per run. TDAA Dog Registration Numbers may be applied for at the event so that your dog can participate in this trial.

Entries will not be accepted without fees. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry forms. One dog per entry form.

Photocopied entries, without the signed TDAA Agreement attached are NOT acceptable. Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the Trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$25.00 service charge for any returned check(s). Subsequent returned check(s) from the same Exhibitor may result in their being put on a CASH ONLY basis.

Agreement

I/We acknowledge that the "Teacup Dogs Agility Association Rules & Regulations" have been made available to me/us, and that I am/we are familiar with their contents. I/We agree to hold the TDAA, TDAA approved judge and Happy Dog Ranch, LLC (HDR) harmless from any legal claim resulting from said Judge's action under the TDAA Rules, Regulations and Guidelines. I/We agree that HDR has the right to refuse entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Agility Trial and of the opportunity to have the dog judged, I/we agree to hold harmless the directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or things by the act of this dog while in or upon the show/trial premises or grounds or near any entrance thereto, and I/we personally assume all responsibility and liability for any such claim, and I/we further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I/We hereby assume the sole responsibility for and agree to indemnify and safe the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time arising out of or in consequence of my/our participation in this Agility Trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

Instructions

A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of the new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been made to TDAA.
